

Participant Waiver, Assumption of Risk & Release of Liability

Lady Lake Youth Baseball & Youth Softball Inc.

I am the parent or legal guardian of the participant identified in this registration. In consideration for my child's participation in programs, practices, games, tournaments, camps, clinics, and other activities sponsored by Lady Lake Youth Baseball & Youth Softball Inc. ("the League"), I acknowledge and agree to the following:

Acknowledgment of Risk

I understand that participation in baseball and softball involves inherent risks that cannot be eliminated regardless of the care taken to avoid injuries. These risks include, but are not limited to:

- Falls, slips, and collisions
- Being struck by bats, balls, or other equipment
- Running, sliding, and throwing injuries
- Sprains, strains, fractures, concussions, and other physical injuries
- Heat-related illness, dehydration, insect bites, and weather-related hazards
- Risks associated with playing on athletic fields and using sports equipment

I knowingly and voluntarily assume all ordinary risks associated with my child's participation in League activities.

Health Certification

I certify that my child is physically able to participate in baseball and/or softball activities. I agree to inform the League of any medical condition, allergy, injury, or limitation that may affect my child's safe participation.

Medical Authorization

If I cannot be reached in the event of an illness or injury, I authorize the League to obtain emergency medical care for my child, including transportation by emergency medical services when deemed necessary.

I understand that I am financially responsible for any medical treatment provided to my child.

Release of Liability

To the fullest extent permitted by applicable law, I release and hold harmless Lady Lake Youth Baseball & Youth Softball Inc., its Board of Directors, officers, volunteers, coaches, assistant coaches, umpires,

sponsors, agents, and representatives from claims arising from the ordinary risks of participation in League activities.

This release does **not** apply to conduct that cannot legally be waived under applicable law.

Equipment Responsibility

I understand that while the League makes reasonable efforts to provide safe equipment and facilities, I am responsible for ensuring my child uses equipment properly and follows the instructions of coaches, officials, and League representatives.

Code of Conduct

I agree to comply with all League policies, rules, and Codes of Conduct. I understand that failure by my child or family members to follow League policies may result in disciplinary action, including removal from League activities without refund when appropriate under League policies.

Insurance

I understand that the League maintains insurance coverage as determined by the Board of Directors; however, I remain responsible for any medical expenses, deductibles, or other costs not covered by insurance.
